

## GREEN PEEL METHODS - POST TREATMENT SHEET

- These treatments are **NOT suitable** for pregnant or lactating woman
- The Green Peel method performed on your skin may cause slight increased sensitivity, according to method performed. Side effects may include, but are not limited to:
  - ° Touch sensitive tingling
  - Itching
  - Redness
  - Tightness
  - Peeling
- Please ensure that the use of AHA, BHA, Retinol or Benzoyl Peroxide is strictly prohibited when undergoing a GREEN
  PEEL treatment and these products should be stopped 5 days before the peel and only resumed 5 days after the
  peeling process /tingling sensation has completely stopped.
- Therapist cannot wear gloves when performing the green peel as the material can damage the herbs, causing a reaction on the skin.
- For the day of and 2 days following the peel, avoid sweating, exercise, very hot baths/showers
- Clients will always start with Fresh up and then progress to Energy, which is only advised for winter months & only
  done in a course of 3-4 Energy's then back to Fresh Up as maintenance.
- All patients need to have 3x consecutive Fresh Up Green Peels, gradually increasing time and pressure to prepare
  the skin for corrective treatment methods before they can move on to doing Energy.
- Green Peel Treatment time:
  - Fresh up 1 min 30 sec for all first-time clients and can add 30sec or 1 full min (depending on client tolerance and skin condition) on next follow up treatment.
     A maximum of 3 min can be spent on Fresh up.
  - Energy 3min 30sec can increase 30sec or 1 full min (depending on client tolerance and skin condition) on next follow up treatment.
     A maximum of 5 min / 6 min can be spent on Energy.
     (Therapist to use their own discretion and client's sensitivity when increasing time)
- Please be aware immediately following the treatment the skin will have an active sensation especially felt when touch is applied.

**Do not over touch the skin** as this might cause sensitivity or a <u>slight red rash</u> (please note this is not harmful in any way and will not affect the result of the treatment)

Strictly only an area the size of two hands can be treated at a time in a Green Peel treatment, palpitations might be experienced when too large an area is treated due to the depth of the medical treatment.
